This can also clear shipments to any other part of Canada. Shipments of cars or for visitors are excluded. Firewood	Import permit	To be permitted entry into Canada, firewood must meet one of the following conditions: <ul style="list-style-type: none"> • Must originate from a pest-free area • Must originate from an area of identical pest distribution • Must be treated in a CFIA approved manner • Must meet the certification systems as outlined in other pest-specific CFIA forestry policies. 	The implementation of the new firewood policy has begun on March 30, 2002. The importation of uncertified raw firewood from all countries of the world is strictly prohibited.
Fumigation of imported and exported wooden crates	The Canadian Government adopted ISPM-15 (International standards for Phytosanitary Measures Publication 15) Guidelines for Regulating Wood Packaging Material in International Trade (aka NIFM-15) to standardise the treatment of wood packing materials used for the transport of goods. Details of the requirements will be provided as soon as possible.
